2017 Dividends Approved

Common Shares

- Casera's Board of Directors has approved a 2% share dividend to members holding Common Shares of Casera Credit Union on record for the 12-month period ending December 31st, 2017.
- Cash dividends will be credited to members' accounts by January 29th, 2018.
 The credit will be made to members' chequing/savings accounts for nonregistered funds, and credited to registered Surplus Share accounts for registered funds.

Preference Shares

- Casera's Board of Directors has approved a 4% share dividend to members holding Preference Shares of Casera Credit Union on record for the 12-month period ending December 31st, 2017.
- Cash dividends will be credited to members' accounts by January 29th, 2018.
 The credit will be made to members' chequing/savings accounts for
 nonregistered funds and credited to registered Surplus Share accounts
 for registered funds.

Since 1994, Casera Credit Union has returned over \$3.9 million in dividends to its members.

100% Deposit Guarantee

At Casera, all deposits are guaranteed 100% by the Deposit Guarantee Corporation (DGCM) of Manitoba. DGCM is the deposit guarantor for Manitoba's credit unions and is required by law to guarantee without limit, all deposits you make with your credit union. The guarantee, however, does not cover non-deposit instruments, such as common shares, surplus shares, preferred shares, mutual funds and self-administered RRSPs.

DGCM guarantees all money placed in a savings or deposit account, including any interest credited to those accounts. The corporation does not guarantee or insure the equity of a credit union. Equity consists of shares issued by the credit union or other securities and surpluses of the credit union.


What Does an RRSP Mean to You?

From *Understanding RRSPs**

An RRSP allows you to invest money when you can most afford it — during your peak earning years — to build up a comfortable tax-sheltered retirement fund.

The accompanying graph shows the amount you could accumulate by annual RRSP contributions of \$1,000 at the beginning of each year, assuming constant interest rates of 1.5%, 2.5% and 4% per year.

Not only do you invest some money that would otherwise be paid in taxes, but also the earnings of your plan are not taxed until you withdraw them. Since 100% of these earnings can be reinvested and compounded, the growth of your RRSP increases rapidly over the years, as the graph shows.



Your retirement savings will also increase significantly if you make each RRSP contribution as soon as allowed, for example, early in the year.

Travelling this Winter? Don't Forget Travel Insurance

Studies show that many Canadians who travel in Canada (but outside of their home province) don't purchase travel insurance, assuming — often mistakenly — that their provincial government or employee health plans will cover everything. All too often that turns out not to be the case.

Expenses such as prescription drugs, air ambulance service, X-rays and other costly procedures may not be covered by your plan when you're outside Manitoba — even if you're still in Canada. Therefore, if you're planning a winter vacation, it's a good idea to include purchasing travel insurance as part of your trip. It's also a good idea to carry proof of that travel insurance with you, along with the name and phone number of the insurance provider. You may also want to leave a copy of the details with a neighbour or close relative, just in case you lose your copy.
